## NOTICE OF ENERGY EFFICIENCY AND ENERGY CONSERVATION TASK FORCE JANUARY 25, 2021 MEETING

**January 19, 2021** 

FORMAL CASE NO. 1148, IN THE MATTER OF THE INVESTIGATION INTO THE ESTABLISHMENT OF ENERGY EFFICIENCY AND ENERGY CONSERVATION PROGRAMS TARGETED TOWARDS BOTH AFFORDABLE MULTIFAMILY UNITS AND MASTER METERED MULTIFAMILY BUILDINGS WHICH INCLUDE LOW AND LIMITED INCOME RESIDENTS IN THE DISTRICT OF COLUMBIA,

On October 19, 2017, the Public Service Commission of the District of Columbia ("Commission") opened an investigation into the establishment and implementation of energy efficiency and energy conservation ("EEEC") programs targeted towards both affordable multifamily units and master metered multifamily buildings, which include low- and limited-income residents in the District of Columbia as a result of the Exelon Corporation and Pepco Holdings, Inc. merger commitment set forth in Order No. 18148. The Commission held numerous roundtables and working group meetings focused on implementing: (1) a Whole-Building, Deep Energy Retrofit Program ("Deep Retrofit Program") targeted primarily towards both affordable multifamily units and master-metered multifamily buildings in the District, which include low- and limited-income residents; and (2) consumer education and outreach measures related to the implementation of the program.<sup>2</sup>

On October 11, 2019, the Commission established the Energy Efficiency and Energy Conservation Task Force ("Task Force") to prepare and issue a request for proposals to hire a recommended program implementer to assist in finalizing the details and administration of the Deep Retrofit Program.<sup>3</sup> On September 23, 2020, the EEEC Task Force filed a proposed Recommendation to select the International Center for Appropriate & Sustainable Technology ("ICAST") to be the implementer for the Deep Retrofit Program.<sup>4</sup> The Commission on November 20, 2020, approved the EEEC Task Force's recommendation, established ICAST as the program implementer, and directed the Task Force to file with the Commission the final program design as approved by the
